
Report on material decisions of the Special Purposes Committee

The Special Purposes Committee met on-line on Thursday 19 January 2023. The agenda items below reflect the material decisions made by the Committee at its meetings on 17 November 2022 (not previously considered by Council) and 19 January 2023. Agenda Item E – Following an Expression of Interest Process: Recommendation to Council for appointment of Council members to Advisory Committees

Following an expression of interest process the Committee considered appointments to the Advisory Committees, with due regard to the current membership of the Committee, term history, succession planning to ensure continuity and the skillsets required by each of the relevant Advisory Committees.

Following discussion, the Committee agreed to recommend the following appointments to Council for approval:

- That Ms Dorothy Donovan be appointed to the Regulatory and Professional Policy Committee for a term of two years, or until such time as she ceases to be a member of Council, whichever the sooner.
- That Ms Katherine Morrow be appointed to the Regulatory and Professional Policy Committee for a term of two years, or until such time as she ceases to be a member of Council, whichever the sooner.
- That Mr Sean Reilly be appointed to the Performance and Resources Committee for a term of two years, or until such time as he ceases to be a member of Council, whichever the sooner.
- That Ms Avril Ryan be appointed to the Performance and Resources Committee for a term of two years, or until such time as she ceases to be a member of Council, whichever the sooner.
